Paralegal Internship Program

DESCRIPTION

The Alameda District Attorney's Office offers an empowering Paralegal Internship Program offering *practical experience* with Alameda's *most progressive* prosecution team in the nation. Under the general direction and supervision of a Deputy District Attorney or Certified Paralegal, interns will perform a variety of specialized paralegal functions including some combination of the following: drafts legal documents; conducts legal research and prepares written memoranda; prepares documents for use in pretrial and trial proceedings; creates and maintains legal files, trial notebooks, indices and supervises case and file management systems.

This Programs runs a typical eight (8) to twelve (12) weeks in the Fall, Spring, and Summer. Interns will be supervised by a Deputy District Attorney or Certified Paralegal in the Criminal or Civil Division of the Office assisting with casework and trial preparation.
