





# Alameda County Clean Slate Resources

The Alameda County District Attorney's Office offers you the possibility of cleaning up your criminal history. You may either file petitions on your own (pro per) or seek the assistance of a pro bono or low-cost law agency to file them on your behalf.

Manuel Courthouse (WWM), 661 Washington Street, Oakland, California, 94607.
